Moreover, Trigone can now benefit from state-of-the-art technological support to sustain its development.”

NRB becomes the sole shareholder of Trigone. Trigone will remain a separate legal entity, thus respecting the specificities of this organisation. Denis Burtin will continue to carry out his mission as CEO.
